

## **Consent to disclosure of tax return information under IRC Section 7216 Disclosure Consent Requirements**

Tax From US is a nonresident tax preparation software helping international students and temporary workers in the US to file their Nonresident Federal, State and FICA tax returns and apply for an ITIN. Due to the international profile of the Tax From US LLC clients and their tax needs, Tax From US LLC use international team of tax specialists to ensure correct tax calculation and right application of international taxation treaties. Tax From US is the online tax preparation software built and developed by Tax From US LLC and serviced by Tax From US LLC international team of tax professionals and software developers. In order to meet requirements of the IRS code and Federal law in the USA, we request that you provide consent to Tax From US LLC so that we can share and store your personal data, including your SSN, employment and tax data with our international tax team to ensure your tax return is compliant.

Federal law requires this consent form to be provided to you. Unless authorized by law, we cannot disclose your tax return information to third parties (our international partners will qualify as third parties as they are employed by Tax From US LLC partners, not by Tax From US LLC directly) without your consent for purposes other than the preparation and filing of your tax return and, in certain limited circumstances, for purposes involving tax return preparation. If you consent to the disclosure of your tax return information, Federal law may not protect your tax return information from further use or distribution. You are not required to complete this form, this consent is completely voluntary. Tax From US LLC may decline to provide you with service or change the terms of service that we provide to you if you do not sign this form. If you agree to the disclosure of your tax return information, your consent is valid for 12 months.

This consent to disclose may result in your tax return information being disclosed to a tax return preparer located outside the United States, including your personally identifiable information such as your Social Security Number (SSN) or Individual Taxpayer Identification Number (ITIN). Both the tax return preparer in the United States that will disclose your personally identifiable information and the tax return preparer located outside the United States which will receive your personally identifiable information maintain an adequate data protection security as required under 26 U.S.C. Section 7216 to protect privacy and prevent unauthorized access of tax return information.

If you consent to the disclosure of your tax return information, US Federal agencies may not be able to enforce US laws that protect the privacy of your tax return information against a tax return preparer located outside of the US to whom the information is disclosed. If you agree to allow Tax From US LLC, through the use of Tax From US online tax preparation software, to disclose your tax return information, including your personally identifiable information to Tax From US LLC staff and partners for the purpose of providing assistance in the preparation of your individual income tax returns, please check the box that appears on the registration page.
